

## **2021/2022 ADMISSIONS POLICY FOR THE NURSERY CLASS**

If your child was born between 1<sup>st</sup> September 2017 and 31<sup>st</sup> August 2018 then you can apply for a place for them at our nursery for September 2020.

The nursery is managed by Our Lady's Catholic Primary School. The 34 available places are split between applicants completing the St Michael's Nursery application forms and applicants completing the Our Lady's application forms.

### **30 Hours Per Week Funded Nursery Provision Offer**

The Government has proposed changes to the funding of Early Years provision for 3 and 4 year olds from 2017. As a result of these changes, Camden Local Authority will no longer fund full-time (30 hours per week) Nursery provision from September 2017. Instead, schools will receive funding for only the 15 hours of free Nursery entitlement and the children of working parents who meet the criteria will become eligible for an additional 15 hours funded childcare. In order to try and support the school meeting the cost of the full time provision offered to all children, working parents who are eligible for the additional 15 hours of funded Nursery hours will be asked to apply for this funding. The school office will provide details with more information on whether or not they are eligible to apply for this additional funding and how to apply.

Nursery children are non-compulsory school age and the following procedures and criteria will apply.

### **Application Procedures and Timetable:**

To apply for a place at Our Lady's and St Michael's Nursery, you will need to complete and return the **Supplementary Information Form (SIF)** attached to this policy and return it, in person, to the school office, accompanied by the child's Certificate of Baptism and proof of residency by **15 January 2021**.

**Please also be aware that admission to Nursery class does not guarantee admission to Reception class and Years 1 to 6. Parents must separately apply for a primary school place, following the published Admissions Policy for Reception class and Years 1 to Year 6 classes for the year of admission.**

### **Pupil Numbers**

The Governing Body will ensure that the number of pupils in each year group will be such as to conform to statutory legislation. In accordance with the Government's policy to limit class sizes, a maximum of 34 pupils will be admitted to the Nursery class. The Governing Body proposes to admit 17 pupils who are Our Lady's applicants and 17 pupils who are St Michael's applicants.

### **Oversubscription criteria for Our Lady's applicants**

Whenever there are more applications than places available, priority will always be given to Catholic applicants in accordance with the oversubscription criteria listed below.

### **Nursery Class applications**

In order to make a full application for a place in the School's Nursery Class you should complete a St Michael's and Our Lady's Nursery Application Form and hand it in at **Our Lady's school office**.

## Oversubscription Criteria

Where there are more applications than places available, places will be offered according to the following order of priority:

**In prioritising applications in each of the below oversubscription criteria, first priority will be given to children who will have a brother or sister attending a Reception, Infant or Junior class in Our Lady's Catholic Primary School at the proposed date of admission.**

1. Catholic 'looked after' children and Catholic children who have been adopted or made subject to child arrangements orders or special guardianship orders, immediately after having been looked after.
2. Baptised Catholic children who are resident in the parish of Our Lady of Hal (a map is included as an appendix )
3. Other baptised Catholic children.
4. Other "Looked After" children and children who have been adopted or made subject to child arrangements orders or special guardianship orders, immediately after having been looked after.
5. Children of other Christian denominations whose parents wish them to have a Catholic education.
6. All other applications.

### Tie-breaker

In the event of there being insufficient vacancies to offer places to all applicants in any of the categories detailed above, priority will be given to children whose parents'/carers' residential address is the shortest distance from the main gates of Our Lady's School when measured in a straight line on a map. Distances will be measured from the front door of the applicant's home address to the main entrance of the School using Camden's distance measuring system.

### Twins or multiple births

In cases where multiple siblings tie for the last available place, then all will be offered a place, even if this exceeds the planned admission number.

### Waiting List

Unsuccessful candidates will be offered the opportunity to be placed on a waiting list. This waiting list will be maintained in order of the oversubscription criteria and not in the order in which the applications are received or added to the list. Names are normally removed from the list after one full year unless parents/carers submit a written request asking for their application to remain on the waiting list.

Children ‘looked after’ immediately before the order is made qualify in this category.                        |
| <b>Special Guardianship Order</b> | A special guardianship order is an order under the terms of the Children Act 1989 s.14A which defines it as an order appointing one or more individuals to be a child’s special guardian(s). A child who has been ‘looked after’ until the order is made qualifies under this category. |
