<p><b>Background:</b>          The school currently has no pupils or staff with significant disabilities. Our access routes cause difficulties for wheel chair users, although we have a ramp to the hall, lower playground and back door of Reception classroom – this allows access to all areas on the ground floor. All other classrooms are located on the three levels above, which have no facilities for wheelchair users. The staff room is located on the 2<sup>nd</sup> floor. All Toilets (adults and pupils) have non slip flooring. The school is carpeted throughout to suppress noise levels, provide safe surfaces for children and staff and visually enhance the environment. Acoustics in the hall are not good because of the height of the ceilings.</p> <p><b>Recent improvements:</b>          Signage improved for fire safety.
